

## The Great Betrayal

Pfizer's trial documents released by court order prove genetic C19 injections cause far more harm than C19. Biological reactions to the ingredients damage organs and immune systems, often leading to sudden death. In 2021 and 2022 deaths rose precipitously in the most-injected populations, including in younger people.

SARS-COV-2 and its numerous variants have infection fatality rates (IFRs) on par with seasonal influenzas, and caring doctors identified cheap, effective, and safe medicines by March 2020, meaning there was no emergency. A Johns Hopkins study of 48,000 children showed most have zero risk of dying from C19, while in Pfizer's trials more children in the injected group suffered repeated illness and more died.

Corrupted officials manipulated financial incentives, testing, and reporting to inflate C19 death counts and drive fear, priming citizens to accept destructive interventions and experimental products. Top officials knew about low IFRs and medicines but suppressed this knowledge in favor of Emergency Use Authorizations (EUAs), costing thousands of lives.

Over 150 studies highlight the superior durability, efficacy, and safety of natural immunity, yet, in keeping with a corrupt agenda, the FDA has authorized toxic injections, even for infants, children, and pregnant women.
