Respect Protects and Uplifts

Respect for human rights protects and uplifts individuals, families, and societies. Tolerating abuses leads to needless but grievous injuries. Over 400 studies document the harms caused by rights-violating pandemic responses imposed around the world (Brownstone.org).

Beginning in March 2020, official suppression of preventatives and early treatments, good for all variants, led to 85% of US deaths with or from COVID-19 (Drs. Peter McCullough and Harvey Risch). This tragedy unfolded because FDA acknowledgment of existing medical countermeasures would have ended the declared emergency and blocked Emergency Use Authorization (EUA) for experimental genetic injections.

As long as products fall under EUA, the PREP Act grants immunity from tort liability. For Pfizer to gain long-term immunity under the Vaccine Injury Compensation Program (VICP), the FDA would need to grant full approval to Pfizer's injections for use in school-aged children or pregnant women, followed by the CDC adding the product to its list of formally recommended shots. Proof of willful misconduct disqualifies immunity.

No long-term safety data exist for the genetic injections, yet officials continue to claim they are safe. To date in the US, the experimental products have been linked to more than 300,000 deaths and millions of injuries. As for effectiveness, early trial data showed *absolute* risk reduction at 1% or less. Pfizer has a long history of criminal conduct, including fraud.

No healthy children have died from COVID-19, anywhere in the world, yet hundreds, going on thousands, have been injured or killed by injected mRNA instructing cells to manufacture toxic spike proteins or by lipid nanoparticles accumulating in vital organs, notably the brain, heart, liver, spleen, bone marrow, and ovaries.

Despite these horrors, some governors, including our own, brazenly attempt to lure children into participating in the experiment. New York City's mayor has attempted to mandate injections. Sanjay Gupta, CNN's doctor, has stooped so low as to use Sesame Street as a forum for propagandizing and enticing children.

Children have also been harmed by requiring them to wear masks; by requiring the adults in their lives to wear masks; by causing them to fear infecting others; by causing them to doubt their natural immune systems; by teaching them to place responsibility for their health on external entities and products; and by unjustly disrupting their lives in numerous ways. We have failed to protect human rights, even of innocents.

For almost two years, the people of the world have endured despotism disguised as "science." Corrupted entities intend for government-corporate-foundation-NGO partnerships to

medically and digitally manage every individual in the world, from cradle to grave (HR-550), including endless pharmaceutical interventions. They also seek to convince us to permanently embrace censorship, mandates, negation of financial and personal privacy, and segregation, as essential tools for maintaining "public safety."

Please consider joining those of us working toward the opposite: A world embracing solid protections of inalienable human rights, including of a natural human body and natural well-being. A world supportive of individual liberty, privacy, and personal responsibility. A world encouraging honesty, integrity, and genuine caring and community.
